

**ORDINANCE NO. 2026 -829**

**AN ORDINANCE AMENDING RATES FOR WATER AND SEWER SERVICE  
IN THE VILLAGE OF ALEXIS**

WHEREAS, since the Village of Alexis last amended its water and sewer rates, substantial increases have been experienced by the Village in the cost of providing water and sewer services to the residents of the Village of Alexis; and

WHEREAS, an increase in said water rates and sewer rates is necessary to improve and continue to provide the residents of the Village of Alexis with quantity and quality of water and sewer services.

BE IT, THEREFORE, ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF ALEXIS, as follows:

Section 1: All previous ordinances of the Village of Alexis establishing monthly water and sewer rates are hereby repealed and, in place thereof, has enacted the following water and sewer rates for the Village of Alexis.

Section 2: Each consumer shall pay the following minimum monthly charges, commencing on May 1, 2026.

**Rate 1: Water and Sewer Inside the Village Limits**

<u>Operating Fund</u>	<u>Sewer Fund</u>
\$ 27.79 for the first 1,000.00 gallons	\$ 25.87 for the first 1,000 gallons
\$ 0.71 per 100 gallons over 1,000 gallons	\$ 0.51 per 100 gallons over 1,000 gallons

**Rate 2: Water and Sewer Outside the Village Limits**

<u>Operating Fund</u>	<u>Sewer Fund</u>
\$ 55.58 for the first 1,000.00 gallons	\$ 25.87 for the first 1,000 gallons
\$ 1.42 per 100 gallons over 1,000 gallons	\$ 0.51 per 100 gallons over 1,000 gallons

**Rate 3: Water or Sewer Only Inside the Village Limits**

<u>Operating Fund</u>	<u>Sewer Fund</u>
\$ 27.79 for the first 1,000.00 gallons	\$ 25.87 for the first 1,000 gallons
\$ 1.42 per 100 gallons over 1,000 gallons	\$ 0.51 per 100 gallons over 1,000 gallons

**Rate 4: Water or Sewer Only Outside the Village Limits**

Operating Fund

\$ 55.58 for the first 1,000.00 gallons

\$ 1.42 per 100 gallons over 1,000  
gallons

Sewer Fund

\$ 25.87 for the first 1,000 gallons

\$ 0.51 per 100 gallons over 1,000  
gallons

Section 3: Except as herein modified the Ordinance Prescribing Regulations for the Use and Operation of the Combined Waterworks and Sewage System and Amendments thereto shall remain in full force and effect.

Section 4: This ordinance shall take effect upon due publication, passage and approval thereof on May 1, 2026.
